Q.1 Which course is provided by the college?

Ans. RSLW provides B.A.,LL.B (five year integrated course)

Q.2 What is the duration of course?

Ans. Duration of course will be 5 years (10 semester).

Q.3 What is the admission policy?

Ans. The candidate must have completed 10+2 examination with –
Minimum 50% for General Category
Minimum 47% for OBC Category
Minimum 45% for ST/SC Category
Along with Personal Interview

Q.4 Which is the affiliating university?

Ans. Dr. Bhimrao Ambedkar Law University, Jaipur.

Q.5 How many seats does college offer?

Ans. 66 (EWS 6)

Q.6 What is the fee structure for course?

Ans. Rs. 40,000/- per semester.

Q.7 Is the college approved by Bar Council of India?

Ans. Yes. RSLW is approved by the Bar Council of India.

Q.8 Whether it is a co-educational college?

Ans. No. The college is exclusively for women established in order to extend the outreach of women's education.

Q.9 Is there any entrance test?

Ans. Due to Covid-19 outbreak admission is on merit base and personal interview though students who had undergone any entrance test (RULET/CLAT/LSAT) would be preferred.

Q.10 What is the college timings?

Ans. College is open from 9am to 3pm presently classes are conducted online according to time-table.

Q.11 Whether hostel facility is provided by the college?

Ans. Yes. In house facility is available for students, rooms are available on sharing basis.

Q.12 Whether AC rooms are available in hostel?

Ans. Yes. AC rooms are available for students in Hostel (at extra charges).

Q.13 Is there any uniform in the college?

Ans. To maintain discipline, the college has prescribed professional dress code for the students.

Q.14 What is the exam pattern?

Ans. Exam will be conducted on semester basis i.e. likely to be held in the month of December and June.

Q.15 Does the college provide any practical training for developing advocacy skills?

Ans. Yes college organises multiple events in order to enhance the advocacy skills like Moot Court Competition, client counselling, drafting, pleading in order to inculcate practical learning.

Q.16 Whether college provide any assistance for internships?

Ans. Yes, college provide assistance for internships and for this college has its association with NGO's, law firms, district court, high court, supreme court.

Q.17 What are the job opportunities after B.A.,LL.B?

Ans. A law graduate can be a law officer, legal assistance, legal advisor in any area of business requirement. She will be preferred for posts in banks, companies, railways and other central/state government officer, LPO's, academics etc. She can also appear in judicial examination.
